#### THIS IS IMPORTANT - PLEASE READ

Do you know what this means?

If you "See Something, Say Something" and Call 911 or Crime Stop 602-262-6151

If there is someone, is ringing your doorbell in the middle of the night....

If there is someone acting strangely in the middle of the night, in the street....

If there is someone roaming around the neighborhood, and it is obvious that the person does not belong in Northtown....

If there is someone who is trying to get into the Pool area or Clubhouse, and they do not belong in Northtown....

#### Say Something — Call 911 or Crime Stop 602-262-6151

It would be a wise idea to put the Crime Stop phone number in your cell phone. That will allow you make that call as the situation is happening, you do not have to wait until later to call someone here in Northtown. Do not feel that you do not want to disturb the police; make the call - they want you to call. This is their job to protect and keep us safe.

After you have spoken to the police, you can contact me 602-689-9696 to let me know that you have called for assistance; but please call the police first.

If you happen to be in the area when the police arrive at the situation, and you have the opportunity to speak with the officer, please let them know that the Association has an "Authority to Arrest" on file. This gives them another tool to work with to keep our neighborhood safe for all of us.



#### President: Jeannie King

Greetings Fellow Northtowners:

While the summer is hot and one thinks of lazy peaceful summer evenings, it is not that way lately in Northtown. We have had several major violations you need to be aware of, and we have some possible strategies.

One morning at the pool, men's clothing was found in the trash, small empty bottles of cinnamon whiskey were strewn about, and all the pool noodles were in the pool. This is a major violation and disrespect of our Northtown property.

The lock on the outside women's bathroom door was broken with some of the hardware missing, and someone spray foamed the lock to the pool area. We continue to find the pool gate door propped open or allowed to close so slowly it does not lock. One morning a resident found a screw in the Clubhouse door frame so the door would not lock. Dirty dishes were found in the kitchen sink, and a bucket of water left on the floor.

We are working on getting cameras for the outside of the buildings and the pool and better lighting for the back of the Clubhouse. The underwater pool lights are working at night, and we are working to get the outside lights on a dusk-to-dawn system.

**What can you do?** Make sure the pool gate is locked every time you enter or leave. Do not loan your key to anyone. Each household is allowed 4 guests, and the resident must be present when at the Pool. If you do not know the person, introduce yourself, ask their name and where they live. An evasive answer probably means they do not belong here. Since all Northtown is private property, police have the right to arrest people that do not belong here. Do not forget to turn off lights and fans when you leave the Pool area and ensure the gate and doors are locked.

Safety concerns reported last month have been resolved. Our electrical room door on the end of our Clubhouse was blowing open even when locked, so the deadbolt hole was drilled and the deadbolt now has room to fully engage and should stay locked.

We will soon have the CC&Rs reviewed and revised. We are asking for volunteers to proofread these. Please contact Emmy Morales or Jeannie King if you can help.

Please feel welcome to come to the Board meetings!

#### Vice President: Emmy Morales

The Document Review Work Group reviewed the Fine & Penalty Policy and created two Fine Schedules: one for Weeds and one for General. The changes made were minimal focusing on making the documents easier to understand.

The two Fine Schedule amounts were increased and are still below most HOAs. As a Board, we sincerely want members to abide by the rules and not have to pay a fine. This Fine & Penalty Policy was approved by the Board and will go into effect September 1, 2024.

Hope you are all doing well with this heat!! I'm happy that the Dance/Potluck and the Carwash went so well. All had a good time. The Youth Group did a fabulous job washing cars, and we learned a few things to do and not to do for the next one. Oh my gosh, it was sooo HOT! #### Architectural Control/Compliance: Dennis Franks

Included in this newsletter, you will find the revised Fine & Penalty Policy and Procedure along with the Fine Schedules, one for Weeds and one for General. The revisions show deadlines, reoccurrence periods and increased Fine amounts. More than anything we would like Members to abide by the rules and not have to pay a fine. Some people are getting very behind on their Fine payments, and we kindly ask that this be rectified.

If you have weeds, you may not realize that when your weeds go to seed the seeds blow into other peoples' yards and makes more work for everyone else. We get calls from people who are very unhappy about the neighbor's weeds.

#### Facilities: Susan Nusall

This is a reminder for all Northtown residents that the use of the Clubhouse requires each of us to adhere to Northtown's Clubhouse use rules. It means you understand that you are personally responsible for any, and all damages occurring during your use of the Clubhouse, and that you are responsible for returning Northtown's property to its original condition.

It was disappointing to find that the Clubhouse door was being held open by a screw inserted in the door frame, there was garbage in the kitchen, dishes were not cleaned properly and left in the drying rack, kitchen drawers were left open, and a utensil was found thrown in the garbage. Please be respectful of the facility and rules so we can continue to have the privilege of using the community Clubhouse. You must have a reservation to use the Clubhouse for your party or event.

#### NORTHTOWN HOMEOWNERS' ASSOCIATION, INC.

#### Fine & Penalty Policy and Procedure

Any infraction of any provision in Northtown's Plat Stipulations, CC & R's, or Rules (including Common, Pool, and Clubhouse Rules) by any Member, resident, family member, tenant, guest, or agent of said owner/resident may result in the levy of a fine and/or loss of Common Area privileges. Members are responsible for the actions of their tenants and/or guests. This policy does not exclude any other penalties or remedies available to the Association pursuant to the above referenced documents and/or Arizona State Law. These procedures shall be modified to the extent State law governing penalties and notice requires.

**FIRST NOTICE:** A written notice shall be sent by USPS mail to the Member citing/quoting the specific Northtown deed restriction or rule of the alleged violation with instructions for that Member to either correct the violation or receive a fine according to the appropriate fine schedule within 21 days from the date of 1<sup>st</sup> written notice. **Note:** there are two schedules. One is for weeds, and one is for general violations.

The Member may respond in an email or by certified mail to the address indicated on the notice to request a hearing before the HOA Board of Directors concurrent with the next Regular Board Meeting to occur over 15 business days after the Board receives the request for hearing. No fine or penalty may be levied until this first 21day notice has expired or a requested hearing has been held.

Per ARS 33-1803, if a hearing is requested, the Association must reply in writing within 10 business day of receipt of said request with instructions for the hearing and any action will be delayed until the conclusion of the hearing. Such hearing may be held in a closed Board session unless the Member requests a public session. Failure to appear at a hearing requested by the Member may constitute a waiver of the right of the Member to be heard. At such a Board hearing, any determination by the Board of Directors shall be final and binding.

**SECOND NOTICE:** Failure to either correct the violation or request a hearing within the time frame allowed (21 days) the Member will be assessed the fine. For a reported reoccurrence of a notified violation within 90 days of a prior notice, the Member shall be given written notice of an initial fine being assessed against their lot in the amount per the appropriate fine schedule. (A copy of this policy shall also be included with the second notice's mailing.)

THIRD NOTICE: Will result in an additional fine per the appropriate schedule.

**FOURTH NOTICE:** Will result in an additional fine per the appropriate schedule. For a reported reoccurrence of a notified violation within 90 days of a third notice or failure to correct the violation and pay all accrued unpaid fines by the end of the above 30-day period shall result in a \$125 dollar fine assessed for each additional 30 days. This written notice shall also state failure to correct the violation and pay the accrued fines may result in the HOA pursuing legal action against the Member. Members shall be responsible for all legal fees incurred by the Association if action is brought against them. A fine of \$125 dollars per additional 30-day periods shall continue to accrue against the lot for so long as the violation remains, and the total fine is not paid or be further levied upon the lot for any subsequent reoccurrence of the same violation if within 90 days of a previous notice being sent to that lot.

If a violation persists uncorrected, the assessments continue to add to the total monthly. After the 5<sup>th</sup> notice, a subsequently numbered Assessment Notice will be sent and shall continue monthly including the monthly \$125 assessment until resolved.

All amounts accumulate until paid: both weed fines and general fines.

Our best suggestion is that everyone have a successful weed elimination strategy with back up help as needed pre-arranged before there is a need. This is to include periods you will be away such as on vacation or living for a period of time someplace else.

## Crab Salad

(Taken from internet 12 Tomatoes)

- $\frac{1}{2}$  cup mayonnaise
- 1 tablespoon white vinegar
- 1 tablespoon chopped parsley
- 1 teaspoon lemon juice
- $\frac{1}{4}$  cup sliced green onions

Kosher salt & freshly cracked black pepper, to taste

1 lb. imitation crab meat, cut into pieces

4 to 6 rolls, for serving.

In a bowl, combine mayonnaise, vinegar, parsley, lemon juice, green onions, sale & pepper.

Gently fold in crab meat, folding to completely combine.


Cover tightly with plastic wrap & refrigerate for a minimum of 2 hours. (Can be kept refrigerated for 5 days).

#### Northtown Organizations and Clubs:

Northtown has several organizations and clubs **open to all residents** that operate within the boundaries of Northtown but are not an official part of Northtown Homeowners' Association. They are as follows:

#### KOFFEE KLATCH

Meetings are held Thursdays in the Northtown Clubhouse. Check the Newsletter calendar and Koffee Klatch article each month for dates and times.
